Mechanical Parts Sales Incentive January - March 2025

Parts and Service Managers





The Portland Region is promoting a strong start to 2025 with the launch of our "All in Overland Trek" Mechanical Parts Incentive. Dealerships will compete to win an exhilarating overlanding trip in the summer of 2025. Please see below for program details!

Incentive Criteria

January 1 - March 31, 2025

Mechanical Parts Purchases

• Every dollar in purchases is tracked during the contest period

Mechanical Parts Sales

• Every dollar in sales is tracked during the contest period (Mechanical wholesale is excluded from this calculation)

Net Sales Objective Qualifier

• Dealership must achieve combined contest net sales objective to be eligible to win.

Bonus Criteria

Upon completion of each bonus criteria, dealership receives a 10% bonus multiplier on top of their total mechanical sales and purchases dollar amount. Multiplier is applied at the end of the incentive.

• Example:

- Total contest sales and purchases equal \$1,000,000 and dealership achieves <u>time in service multiplier</u> dealership ends with \$1,100,000
- Total contest sales and purchases equal \$500,000 and dealership achieves <u>TPCO multiplier</u> and <u>SmartPath Service multiplier</u> dealership ends with \$600,000

Time in Service

1 Hour or Less Score (10% multiplier)

- If 60% of customers are under an hour dealership qualifies for multiplier.
- Score is based on the dealerships three-month average (contest duration)

Toyota Parts Center Online

Enrollment in Toyota Parts Center Online (10% multiplier)

• If dealership is enrolled or enrolls in Toyota Parts Center Online during the incentive dealership qualifies for multiplier.

SmartPath Service

Enrollment in SmartPath Service (10% multiplier)

• If dealership is enrolled or enrolls in SmartPath Service during the incentive dealership qualifies for multiplier.

Program Details and Qualifiers

- Parts and Service managers must be listed in Staff Master and employee at the dealership at time of contest and payout.
- Winning dealerships are awarded one trip. Dealership discretion of which manager is rewarded with the trip. Eligible managers include General Manager, Fixed Ops Directors, Service Managers, and Parts Managers.
- Mechanical Parts Purchases: Net Parts Purchases by dealer via TMNA PASA reporting.
- Mechanical Parts Sales: Mechanical sales sourced from dealer financial statement.
 Accounts: Toyota: 4702T +4755S
- Tiebreaker = highest cumulative Mechanical Part Sales dollars during contest period.
- Contest payout will be in summer of 2025 after the conclusion of incentive.
- Taxes: Individual recipients of the payout may be subject to federal, state, and local tax liabilities. All tax liability is the sole responsibility of the winner and not Toyota Motor North America or Toyota Motor Corporation. Toyota will report all applicable amounts to the Internal Revenue Service.
- Dealers out of compliance with PANT Bulletin 2015-006 (TMS Parts & Accessories Sales Policy 2015) will be disqualified.
- We reserve the right to amend the program details at any point during the program period.
